Sleep Disorders: What Eyecare Professionals Need to Know (2 Hours - COPE: 80889-SD)

## Speaker: A. Paul Chous, MA, OD, FAAO

This course will consider a range of sleep disorders and their impact on systemic health as well as ocular disease. Testing for sleep disorders will be discussed along with therapies for their improvement. Evidence linking hypersomnia, hyposomnia, and obstructive sleep apnea to diabetic retinopathy, AMD, glaucoma and OSD will be presented, along with environmental strategies to improve sleep quality and a range therapies for sleep apnea.

#### 1:30 pm – 3:10 pm Landmark Trials in Glaucoma- What They Mean To Us Clinically (1 Hour - COPE: 82597-GL) Speaker: Eric E. Schmidt, OD, FAAO

Each month more and more studies around glaucoma are released, some of which provide valid data others which muddy the waters. But there are 6 landmark studies in glaucoma that have shaped our decision making process around diagnosis, early treatment, progression and choice of therapy. This course will highlight these landmark studies and discuss the data. A lengthy discussion will ensue as to how we, as clinicians, can put this data into practice to allow us to make better diagnosis and treatment decisions and provide better care for our patients.

#### Detecting Progression in Glaucoma (1 Hour – COPE Pending) Speaker: Eric E. Schmidt, OD, FAAO

This course will delve into progressive glaucoma. Making use of clinical clues and risk factors the attendee will gain a clearer understanding of when the disease is not controlled and how to best react to that. Specific clinical findings and ancillary test results will be used to further our understanding of how to detect glaucoma progression earlier in the course of the disease.
